In the aftermath of the Orrville Dam crisis in 2017 and then the dam failures in Michigan this past summer, dam safety has become a very hot topic. Dam owners are responsible for the operation and maintenance of their facilities. Depending on the purpose of the dam (i.e. hydropower, water supply, flood control, etc.), the regulatory requirements are defined by either state or federal requirements. Dam owners need to have a strong understanding of their roles and responsibilities to allow them to operate these facilities safely and appropriately.
